## Cops overlook handgun in turnstile jumper's waistband



Cops arrested a turnstile jumper and brought him all the way to a police station — and marched him in front of a desk

sergeant — before realizing he was packing a loaded

handgun in his waistband, The Post has learned. Ex-con Billy Walters, 37, slipped through an emergency subway gate at the 149th Street Station without paying the

fare around 11:45 a.m. Tuesday, police said.

Cops cuffed him at the scene before taking him to the Transit District 11 substation near Yankee Stadium, authorities said.

The officers did a quick pat-down of the man during the arrest — but somehow didn't discover the .45 Sig Sauer hanging out of his waistband until they got him in front of the station's desk sergeant, police said.

A photo obtained by The Post shows a cuffed Walters standing in the station, arms behind his back with his shirt raised in the front and the piece's handle in plain view.

"While at the police facility, a secondary, more thorough search incidental to lawful arrest was conducted, where an illegal firearm was recovered from the perpetrator," the NYPD said in a statement.

When Walters was first stopped for farebeating, he allegedly told cops he didn't pay the transit fee because he was late for a court date.

"I didn't pay because I was running late to go to court. I got arrested yesterday," Walters allegedly blabbed to an officer.

He also claimed he had a license for the semiautomatic handgun.

"I have a Pennsylvania license to carry the gun. I carry that gun for protection. Somebody busted my face," he said, according to an arrest affidavit.

Walters, who is homeless, was charged with criminal possession of a weapon and menacing after police eventually found the gun and determined he did not have a New York City gun license, cops said.

They also found a shopping bag filled with 36 smaller baggies of weed on Walters, and he was additionally charged with possession of marijuana, according to law-enforcement officials. The NYPD patrol guide states that a frisk should be conducted as soon as a person is taken into custody — with special attention given to the waistband.

## **DESIGNATION OF BENEFICIARIES**

When you work for the NYPD, you have a variety of financial and other job related benefits that can be overwhelming to keep track of. Beginning in 2018, an update to the New York City Automated Personnel System (NYCAPS), Employee Self Service (ESS) portal, allows members to enter or update their beneficiary designations information so that their designated beneficiary may receive a cash benefit representing all or some of the employees' unused leave balances and for an accidental death benefit offered by the City. This system replaced the "Green Beneficiary Card" that most CMOS completed when they were hired. Now, all MOS, both Civilian and Uniformed, must use the New York City Automated Personnel System (NYCAPS), Employee Self Service (ESS) portal to designate beneficiaries and update their information.

#### Have you entered or updated your beneficiary designations information in ESS?

Do you remember who you named as your beneficiary? Have you had any recent qualifying life events (marriage, divorce, birth of a child) that may have changed your choice of beneficiary? Is it still your wish to have this person as your beneficiary if something unforeseen happens to you?

If you have not yet entered or updated your beneficiary information, or if you have experienced a qualifying life event and need to change or update beneficiary information, you can do so by logging into the ESS application and entering the information using the attached job aid.

For additional information on updating your beneficiary information for unused leave balances and/accidental death benefits, please contact 646-610-4201.

#### **Additional Benefits:**

In addition to designating a beneficiary for your unused leave balances and accidental death benefits, many MOS are entitled to Death Benefits from their Pension System, Union and the Deferred Compensation Plan. These entities are all separate and distinct and require specific paperwork in order to designate or update beneficiary information. For more comprehensive information, it is strongly suggested that you reach out directly to those providers. This information is not carried over to the New York City Automated Personnel System (NYCAPS), Employee Self Service (ESS) portal. Some information to get you started is noted below.

#### **Pension:**

Most CMOS are enrolled in one of two pension systems, either the New York City Employees Retirement System (NYCERS) or the Board of Education Retirement System (BERS).

If you are a member of NYCERS and would like to update or review your beneficiary information, you can contact NYCERS at (347) 643-3000 or visit their website at <a href="https://www.nycers.org/beneficiary-designation">https://www.nycers.org/beneficiary-designation</a>.

If you are a member of BERS and would like to update or review your beneficiary information, you can go to the Board of Education Retirement System (BERS) by following the following link: <a href="https://www.bers.nyc.gov/site/bers/plan-information/retirement-programs.page">https://www.bers.nyc.gov/site/bers/plan-information/retirement-programs.page</a>.

#### **Deferred Compensation Plan:**

SUBJECT: MEDICAL EVALUATION FOR ALL MEMBERS OF THE SERVICE WHO BELIEVE THEY MAY HAVE SYMPTOMS OR HEALTH CONCERNS RELATED TO 9/11

- 1. The Department and the City recommend that all 9/11 exposed members of the service undergo a medical evaluation at one of the World Trade Center Health Program Clinical Centers of Excellence locations within the metropolitan area. All uniformed and civilian members of the service exposed on 9/11 are eligible for an evaluation, as well as treatment and monitoring at the federally funded World Trade Center Health Program.
- 2. The initial and annual evaluation and monitoring visit will be on Department time (excused absence with pay) at one of the World Trade Center Health Program Clinical Centers of Excellence. Members must contact the Medical Division at (718) 760-7606/7615/7623/7626 on the day of the visit and inform the Medical Division that it is a World Trade Center monitoring visit, and must submit verification of the monitoring visit to their operations coordinator upon return to work. In addition, uniformed members of the service are encouraged to keep their Police Surgeon apprised of any illnesses that they may be suffering from. The NYPD Medical Division is available to assist members with their course of care throughout their treatments.
- 3. The following is a summary of the eligibility criteria for the World Trade Center Health Program. If members of the service have any doubt as to whether they meet the criteria, please contact the general information number for the World Trade Center Health Program at (888) 982-4748, or visit the World Trade Center Health Program website at <a href="https://www.cdc.gov/wtc.">www.cdc.gov/wtc.</a>

#### World Trade Center Health Program Criteria:

- 4. Workers and volunteers are eligible for the World Trade Center Health Program if they performed rescue, recovery, debris clean-up, related support services (including, but not limited to, security, traffic or command post operations) or restoration of essential services, within (a) Lower Manhattan, south of Canal Street, and/or (b) the Staten Island Landfill, and/or (c) Barge loading piers or locations operated by the Office of the Chief Medical Examiner; and worked and/or volunteered on-site for four hours from September 11, through September 14, 2001, or at least twenty-four hours during the month of September 2001, or at least eighty hours through the month of July 2002 combined.
- 5. Effective July 1, 2011, the 9/11 Health and Compensation Act (also know as the Zadroga Law) included the following eligibility criteria specifically for law enforcement officers: Participated onsite in rescue, recovery, debris cleanup, or related services at Ground Zero, the Staten Island Landfill or barge loading piers for at least one day during the period starting September 11, 2001, and ending on July 31, 2002.
- 6. In addition, Department vehicle mechanics who performed maintenance or dismantling to contaminated vehicles during the above described time period, regardless of location are also eligible.



#### A SOCIAL SECURITY SCAM

Thanks to Jennifer Leach Acting Associate Director, Division of Consumer and Business Education, FTC for contributing to this article.

Earlier this month, we told you about a growing scam: people pretending to be from the Social Security Administration (SSA) and trying to get your Social Security number or your money. That scam is now growing exponentially. In 2017, we heard from 3,200 people about SSA imposter scams, and those people reported losing nearly \$210,000. So far THIS year: more than 35,000 people have reported the scam, and they tell us they've lost \$10 million. Scammers say your Social Security number (SSN) has been suspended because of suspicious activity, or because it's been involved in a crime. Sometimes, the scammer wants you to confirm your SSN to reactivate it or they will say your bank account is about to be seized, they will also tell you what to do to keep it safe. (Often, that involves putting your money on gift cards and giving them the codes – which, of course, means that your money is gone.)

Your caller ID often shows the real SSA phone number (1-800-772-1213) when these scammers call – but they're faking/spoofing that number.

I received one of these calls a short while ago, as did my daughter Kris, and other potential victims from various locations.

In a different Modus Operandi while with the NYPD we staked out the home of a senior who had received a phone call from a female identifying herself as an employee of the SSA. She told the lady that for a fee she would be able to increase her monthly SS check. When she showed up and made the offer again and accepted the bribe we arrested her.

Three new statewide offices recently opened across the country, in Bismarck, North Dakota; Boise, Idaho; and Helena, Montana. In addition, the Puerto Rico office has expanded their investigative scope to include cases in the U.S. Virgin Islands.

## Hero cop killed in Bronx during hand-to-hand struggle with armed suspect (9/29/19)

A hero NYPD officer was fatally shot early Sunday during a desperate, hand-to-hand struggle with an armed suspect just after midnight on the grounds of the Edenwald Houses in The Bronx.

Officer Brian Mulkeen, 33, a six-year veteran of the department, did not survive three gunshot injuries, Chief of Department Terence Monahan told reporters at Jacobi Hospital, where doctors had worked to save his life.

Sources said Mulkeen had been shot with his own weapon in the head, chest and legs as he and the suspect wrestled on the ground.

The suspect, too, was fatally shot. "Five officers at the location fired their service weapons, striking the man," Monahan said.

The fallen officer's last words, recorded by his body-camera as he wrestled on the ground with the suspect, were "He's reaching for it! He's reaching for it!" Monahan told reporters.

Moments later, "numerous shots" were fired, he said.

"Officer Mulkeen's gun fired five times," Monahan said. "At this point, it is not clear who fired Officer Mulkeen's gun."

The suspect's gun, a 32 caliber revolver, did not appear to have been fired, he said.

"As cops we know how rewarding our profession can be," the chief added, his sadness apparent in his voice.

"But I'll tell you: There is absolutely no worse moment on our job than this. As we stand here this morning, a young man with a bright future who courageously patrolled some of New York City's toughest streets has tragically lost his life."

The deadly encounter happened just after 12:30 a.m., as Mulkeen and two fellow plainclothes officers with the Bronx Borough Anti-Crime Unit, which is based in the nearby 47th Precinct, hopped out of their vehicle to speak with the suspected gang member, Monahan said.

"They were there because of gang activity that included recent shootings," Monahan said.

The suspect, whose name was not released early Sunday, broke into a run, Monahan said.

It was Mulkeen — who lived in Yorktown Heights with his girlfriend, also a cop in The Bronx, with the 44th Precinct — who caught up with the suspect and tackled him first.

It was unclear at what point it had become apparent that the suspect was armed.

"He had a 32 cal revolver. He was seen reaching for his gun," Monahan said.

"Officer Mulkeen was on the ground wrestling with the suspect for an extended period of time," before the gunfire erupted, Monahan said.

The 27-year-old gunman was on probation until 2022 for a narcotics-related arrest from last year, the chief said, and had a burglary conviction from Rockland County. He was pronounced dead at the scene.

Mulkeen "was a great cop," the chief added. "Just last night he arrested a man for possession of a gun in this very same precinct."

Mayor de Blasio joined Monahan and PBA President Pat Lynch in asking all of New York to pray for Mulkeen's heartbroken family — and his grieving NYPD family.

"This is a very, very sad day for our city," Mayor de Blasio said at the press conference.

"We lost a hero this evening ... This is a young man who made a choice to join the NYPD and put his life on the line." (Hero continued on next page)

Mulkeen's mother and father, sister and girlfriend had rushed to Jacobi hospital, the mayor said. "We broke the news to them and one of the things they told us, even though their grief, was that Brian made a choice. He wanted to leave civilian life ... he wanted to protect our city ... he gave his life for all of us."

A shaken Lynch called the suspect, "This soulless individual," and lamented of the family, "Their hero — our hero — is not coming home."

Earlier Sunday, police radio transmissions <u>had recorded the worried panic of officers at the scene</u>. "Shots fired shots fired guys! I need a bus! I need a bus!" a male officer shouted, using police jargon for an ambulance.

"Laconia and 229!" another shouted of the shooting location.

"There was a cop lying on the floor and another guy who looked like he'd been shot in the eye," witness Sara Diaz, 56, told The Post. "Oh my god, I got so nervous."

#### **Questions and Answers**

February 1, 2019 Retiree Health and Welfare Fund Benefits Improvements

- Q: My dependent child is currently covered as a full-time student. Do I still have to provide certification of student status?
- A: No, certification of full-time student status is no longer necessary. All otherwise eligible dependent children are eligible for coverage through the end of the month during which the dependent child attains the age of 26 regardless of student status. This is consistent with the eligibility rules for the Active PBA Health and Welfare Fund and the City of New York Health Benefits Program.
- Q: My dependent child is under 26 and is currently covered under the Retiree Health and Welfare Fund through COBRA. Do I still have to pay COBRA premiums?
- A: No, your dependent child is eligible for coverage as your dependent until the end of the month during which he or she attains the age of 26, at which time COBRA can be elected again.

  Dependent children currently enrolled through COBRA, and who will be under the age of 26 as of January 31, 2019, will be re-enrolled as non-COBRA dependents and you will no longer be billed for COBRA premiums. If you have already paid COBRA premiums beyond January 31, 2019, those premiums will be refunded.
- Q: When I retired I elected COBRA for my dependent child under the Active Health and Welfare Fund because he or she was not eligible for benefits under the Retiree Fund. What will happen?
- A: Under the new eligibility rules, you may enroll your dependent child(ren) as long as they are under the age of 26. You have the option of keeping COBRA under the Active Health and Welfare Fund until it would normally expire or cancelling it.
- Q: My dependent child is under 26 and previously lost coverage without subsequently electing COBRA. What will happen?
- A: If your dependent child would be eligible under the new eligibility rule and is not currently enrolled as a full-time student or under COBRA, you may re-enroll your child as of February 1, 2019 by submitting a Dependent Child Re-enrollment Form (a copy of which is enclosed).
- Q: Which periodontal services will be covered?
- A: Effective February 1, 2019, all periodontal services currently covered by the Active Health and Welfare Fund's Dental Plan will also be covered by the Retiree Health and Welfare Fund's Dental Plan. These services include osseous surgery and gingivectomy/gingivoplasty. The PBA will notify dental providers of the updated coverage.
- Q: Can I obtain coverage for periodontal services that were performed prior to February 1, 2019?
- A: No, the change is effective for services performed on or after February 1, 2019.




